# Senior Nutrition and Meals in Mecklenburg County

**Senior Citizens Nutrition Program (SCNP),** commonly also known as the "Meals on Wheels Program" is more than a meal service program for individuals 60 years and older residing in Mecklenburg County. We believe, this program positively impacts the health and independence of seniors because the services we provide promote nutritional, physical and social well-being.

SCNP offers three types of services to eligible customers. They are: 1) Home Delivered Meals 2) Congregate meals and activities and 3) Nutritional Supplements. There are no income guidelines to receive these services and there is no cost to participate. The program is funded with a combination of federal, state, and county dollars; plus, voluntary contributions from service participants. Participants are under no obligation to contribute; it is entirely voluntary.

#### **Congregate Meal Services and activities**

This service is offered at 19 sites that are conveniently located throughout Mecklenburg County. To learn more about this service, click on <u>congregate meal</u> <u>service and programs</u>.

### **Home Delivered Meal Service**

This service provides home-delivered meals to those seniors determined to be "homebound". A short term twelve-week home-delivered meal service is also available for those seniors recovering from hospitalization or rehabilitation. #### Nutritional Supplements Meal Service

Limited liquid nutritional supplements is provided to seniors with prescribed supplemental nutrition needs to learn more about this service, click on <u>nutritional</u> <u>supplements meal service</u>.

**Congregate Meal Service & Activities** 

This service is offered at over 19 sites located throughout Mecklenburg County. Participants at the congregate nutrition sites meet Monday-Friday between the hours of 9 am and 1 pm to engage in positive, meaningful socialization, exercise and take part in a variety of fun activities, health promotion and educational programs. Volunteer opportunities are also available. At noon, participants eat hot, nutritious and appetizing meals that are planned by a dietitian and catered by a food vendor. #### Who qualifies for this service?

• Mecklenburg County residents, age 60 + and their spouses regardless of age when the older client is a nutrition client

• People under age 60 with disabilities who reside with and accompany eligible people to meal sites

• People under age 60 with disabilities who reside in housing facilities occupied primarily by older adults at which a congregate nutrition site is located

#### Congregate Transportation

## Meals on Wheels in Cornelius, NC

We provide weekly home-delivery of meals to seniors who are assessed to be "homebound", therefore cannot attend a congregate nutrition site, they are unable to shop and prepare food for themselves and they have no reliable support. The goal of this program is to provide a support service to enable senior adults to remain independent in their own homes. Eligibility for home delivered meal services are assessed by a county case worker. For more information about this service or to sign up for this program, please call Just1Call at 704-432-1111.

A short term (up to 12 weeks) home delivered meal option is also available for those seniors recovering from hospitalization or rehabilitation and meet the homebound meal service eligibility as described above. For more information or to sign up for this program, please call our office at 704-336-3144.

Who qualifies for this service?

• Mecklenburg County residents, age 60+ who are physically or mentally unable to obtain food or prepare meals and they have no responsible person who is able and willing to perform this service

• Are unable to attend a congregate nutrition site because of physical or mental impairment

• The spouse of an older person, if one or the other is homebound because of illness or incapacitating disability

How to Apply?

• Individual interested in this service must call Just 1 Call service at 704-432-1111. A medical provider, family member, caregiver, or a friend may call and make the referral for the potential client.

• For short term meal service, individual must call 704-336-3144. Referrals can also be made by a medical provider, family member, caregiver or a friend.

# **Adult Social Work Services (ASWS)**

#### **AVAILABLE SERVICES:**

- Just1Call (J1C) is the single portal of entry for information, referral, and initiation of services. The J1C process begins with an inquiry from a prospective client, family member, a member of the community, or an agency. Our highly skilled intake social workers screen and assess urgent complex requests for assistance via telephone, office, and home visit interviews and help the client access needed resources. See <u>frequently</u> <u>asked</u> questions.
- The **Monitoring Unit** Responds to complaints and monitors licensed Assisted Living Facilities and Family Care Homes to ensure their compliance with state regulations in meeting the needs of residents.
- Adult Protective Services (APS) provides protective services to disabled adults, 18 years of age or older who are alleged to be abused, neglected, or exploited and in need of protection. APS Social Workers evaluate the reports and assess the disabled adult's capacity to consent for services. To report instances of abuse, neglect or exploitation of an older or disabled adult, please call 704-336-CARE (2273) immediately. Your call will be kept confidential.
- The **Caregiver Support Program** provides assistance to family and volunteer caregivers who provide assistance to the loved ones at home. Persons being cared for must reside in Mecklenburg County and be over the age of 60 or have Alzheimer's Disease or other dementia. Services include referrals to community agencies, education, and funding for respite services and supplemental services such as home modifications, nutritional supplements and adaptive equipment. All of this is focused on making the caregiver's role more manageable.

- <u>Kinship Care</u> is the family caregiver support program at Mecklenburg County Department of Social Services for any older relative raising younger children. Thus far participants are grandmothers and grandfathers who are raising their grandchildren. If you are a grandparent raising grandchildren or other relative caregiver of children up to age 17, we invite you to come and be a part this very exciting group of grands. We meet the second Monday of each month at 3205 Freedom Drive, Charlotte, NC 28208. We are located at the corner of Ashley Rd and Freedom Drive. For more information call Just 1 Call at 704-432-1111.
- Guardianship provides services to individuals who have been declared mentally incompetent and who have no one else to assume this responsibility. Social workers aid in locating resources to meet the needs of these individuals in the least restrictive living arrangements.
- Services to Maintain Independence (SMI) Social Workers help older and disabled adults access community resources and other services that will enable the individuals to remain safely in their own homes as long as possible.
- Community Social Work provides social work and case management assistance for adults, seniors and disabled citizens who fall outside of protective services and public assistance services. These clients need supportive services to navigate multiple systems and guide them as they to grow to reach self-sufficiency. Staff work with other County services and external community collaborative partners to connect customers with resources to assist vulnerable and underserved citizens.

#### HOW TO APPLY FOR SERVICES:

# **Mecklenburg Transportation System (MTS)**

The Mecklenburg Transportation System (MTS) provides a variety of transportation services to Mecklenburg County residents.

#### How to Apply for Services

- To apply for Medicaid funded transportation, an individual should contact his/her Medicaid worker.
- To apply for Veterans Transportation, an individual should call the Veterans Service Office 704-336-2102.
- To apply for transportation to a nutrition site, for homebound meal delivery, to a medical facility, or any other location, an individual should contact the Transportation Services Line 704-336-4547.

#### **Description of Transportation Programs and Eligibility Provided by MTS**

#### **Medicaid Transportation**

Adults and children authorized to receive Medicaid transportation are transported to and from a medical destination. CATS bus service is the primary mode of transportation. A Medicaid Transportation Exception Form (5028) is required. Cost: No fare.

#### **Elderly Disabled Transportation Assistance (EDTAP)**

Adults aged 60+ and children and adults with a disability are transported to and from dialysis or chemotherapy. Cost: \$1.50 fare per one-way trip.

#### Elderly General Purpose (EGP)

Adults aged 60+ that are not living in an assisted living facility or nursing home are transported to and from medical appointments, grocery shopping, and

Mecklenburg County Park and Recreation/Senior Centers. Cost: \$1.50 fare per one way trip. \$10.00 for a monthly CATS bus pass.

#### Enhanced Mobility of Seniors & Individuals with Disabilities (5310)

Adults aged 65+ or individuals with a disability are transportation to and from medical facilities, paid employment and grocery shopping. Cost: \$1.50 per one way trip.

#### **Rural General Public (RGP)**

Neither the origin or destination of the trip must be in the non-urbanized area of Mecklenburg County for persons of any age. Door to door service is provided or passengers may choose to e taken from the non-urbanized location to a local Charlotte Area Transit System (CATS). Cost: \$1.50 fare per one way trip.

#### **Veterans Services Transportation**

Qualified veterans are transported to and from Veterans Affairs hospitals in North Carolina and to and from medical clinics in Charlotte. Call the Veterans Services Office at 704-336-2102 for more information. Cost: No fare. Veteran Transportation Online Request

#### Senior Citizens Nutrition Congregate (SCNP)

Transportation provided directly by MTS for adults aged 60+ are transported to and from Mecklenburg County Senior Citizens Nutrition sites for a nutritious meal and social activities. The service is provided directly by MTS drivers. Costs: No fare. Contributions are accepted but not required.

#### **Comprehensive Community Program (CCP)**

Transportation provided directly by MTS for developmentally disabled adults to participating agencies that provide employment and enrichment opportunities. Cost: Sponsoring agency is responsible for cost of service.

Important to Remember: All MTS programs, except Medicaid Transportation, have limited funding available. As a result, frequencies and types of trips may be adjusted.
